	SW opened the meeting and reminded everyone of the meeting etiquette.	
2	Minutes of the Meeting Held on 5th November 2020	
	The minutes of the previous meeting were agreed as an accurate record.	
3	Actions from Previous Meetings	
	<p>NK had responded to PH's query about transport for carers taking their cared for to hospital. NHS transport was only provided for the person receiving medical care, however, Age UK provided volunteer transport similar to a taxi service so there was no reason why a carer could not travel with their cared for. Covid rules meant that the carer was not permitted to enter the hospital unless there were exceptional circumstances.</p> <p>SW noted that no questions had been received for the DWP, as discussed at the last meeting. Questions should be emailed to partnershipboards@healthwatchcornwall.co.uk as soon as possible in order to receive timely responses from the DWP.</p> <p>NK reported that day services for people with learning disabilities and Autism were still closed. Cornwall Council had sent a letter to carers and service users in December - which was also produced in Easy Read format in line with recommendations from the LD and Autism Partnership Boards - which stated that there would be a phased reopening of the Centres from January. Unfortunately, that had not been possible following the announcement of the current lockdown. The Partnership Boards team would request an update and inform the Board.</p> <p>Respite remained an issue and those in crisis, or anybody unable to look after the person they were caring for, were advised to phone the access line at Cornwall Council.</p> <p>A colleague of AM was looking for people who may have used summary care records - a way in which information could be transferred if a carer was not able to attend an appointment with their cared for. The system would allow for carers to pass on information regarding their cared for person in the form of a care record. AM said that during Covid it had been difficult for carers to accompany their cared for to hospital, but during the pandemic hospitals had been given access to an individual's summary care records, containing patient information, medical history,</p>	<p>All members - Questions for DWP</p> <p>MH/NK - Update Board as appropriate</p>

	<p>conditions etc., which was normally held by GP. NHSE wanted the practice to continue as it had been working well.</p> <p>NHSE would like to hear feedback on lived experiences of using the system. Members willing to share a case-study should email partnershipboards@healthwatchcornwall.co.uk to help inform the strategy.</p> <p>JL asked whether summary care notes could be shared with out of county hospitals too, especially in cases where appointments are carried out at Derriford.</p> <p>NK reported that the Healthwatch Cornwall Coronavirus survey, which had gathered people's experiences of health and social care through the pandemic, had been extremely successful. A follow up survey with an element focussed specifically on carers would soon go live. A link would be circulated to the Board.</p> <p>AN added that she had met with colleagues at RCHT to discuss the merging of emergency cards and carers passports into one card which would offer more benefits for carers. All South West Councils were currently working together to unify processes.</p>	<p>AM - investigate and update NK/MH for circulation to Board.</p>
4	Matters Arising	
	<p>There were no matters arising from the minutes of the last meeting.</p>	
5	Updates from Cornwall Council	
	<p>AN provided the following updates.</p> <p>Update on the Carers Strategy</p> <p>The Carers Strategy was currently being finalised and was with senior management for comment. It was hoped that the final version of the strategy could be circulated very soon.</p> <p>New Informal Carers Support Service</p> <p>The tender for new services for informal carers had been published on schedule. The new service would commence from 1 July 2020, offering a wider range of support for carers, including a helpline, wellbeing support, emotional support, training, advice on financial support and peer group support in the local area.</p> <p>The service would bring a new approach to carers assessments and personal budgets. Unfortunately, there was no increase in the budget to provide services to the 63,000+ carers in Cornwall and, with increased demand, it was essential to maximise funding. It was expected that fewer carers would access assessments but they may need advice on accessing carers allowances etc. Assessments would still be available to those that required them, however not</p>	

	<p>everyone would be eligible for a carers personal budget.</p> <p>As detailed in an email circulated by the Partnership Boards Officers, there was an opportunity for three current carers to be involved in the evaluation of the new tender. Participants would be provided with training and would need to attend a presentation from each provider.</p> <p>Current carers covering three different criteria were sought:</p> <p>One working age carer; One carer over 65; One carer who was looking after a person with hidden disabilities e.g. mental health, autism etc.</p> <p>Places would be available on first come first served basis - anyone interested should email partnershipboards@healthwatchcornwall.co.uk.</p> <p>The presentations would take place on 26 and 29 March.</p> <p>Regarding the tender and specification, SW asked whether any carers had reviewed the specification before it was issued. AN advised that carers did not have direct input into the service specification but they were engaged in the co-design of the new service strategy, which was incorporated into the specification for the tender.</p> <p>Covid-19 Vaccinations for Carers</p> <p>Cornwall Council were working with NHS Kernow colleagues to issue communications to inform all carers when they could register for a vaccine.</p> <p>Carers information would be shared with GPs who would contact individuals direct to book their vaccine. There was no need for individuals to contact their GP.</p> <p>AW queried whether the form for carers to register for vaccines would be online. AN advised that it would be online and that there would be a phone number to call. If carers were registered as such with their GP and/or on the Carers Register they would not need to complete the form.</p> <p>AW stressed that many carers do not have access to digital technology.</p> <p>The vaccine was due to be available the following week so time to send letters was short. It was likely that GPs would phone people to book appointments. Cornwall Council were trying to help to ensure as many carers as possible could be reached. Kernow Carers Service would also be in contact with those carers who were registered with them.</p>	<p>AN to ask NHS colleagues if letters would be sent</p>

	<p>Winter Grants</p> <p>Cornwall Council had secured a Covid winter grant to support people in financial hardship due to the pandemic. 80% of the pot was for families and 20% for adults. £50,000 was specifically available for carers.</p>	<p>AN to provide further information inc. eligibility criteria</p>
6	Embrace Care Update	
	<p>DyC updated on the Embrace Programme, a key piece of partnership working between CFT, RCHT, Cornwall Council and other health and care partners.</p> <p>It particularly focused on looking at the outcomes older people were receiving from Adults Social Care, Community Hospitals and Acute Hospitals.</p> <p>Some of the key findings were quite sobering, with 43% of people not getting the right outcome, too many people being transferred into long term residential care homes unnecessarily and people spending too long in hospital beds.</p> <p>Embrace was aiming to establish integrated community teams in 17 different Primary Care Networks across Cornwall, joining NHS and adults social care teams at a local level to work with people from community organisations in providing more care, more locally.</p> <p>That work had stopped due to the Covid pandemic but in April the set-up of the local teams would be restarted and there would be more engagement and discussion with local people at that time.</p> <p>One of the key groups of people to engage with would be carers. DyC was keen to get the Board's view on how best to engage, what would work best and how people with caring responsibilities could be involved.</p> <p>PH highlighted an issue of carers not being consulted when their cared for were discharged from hospital, meaning that the necessary support was not always in place. DyC stated that it was essential to ensure that individuals were not discharged without support and part of the work due to start in April would be around understanding what needed to be done to ensure that carers were involved in designing processes like hospital discharge.</p> <p>He cited one of the more detailed findings from 2019. One of the main reasons that people did not receive the right outcomes, in 18% of cases, was the right type of care not being available. 7% of the cases of people not getting the right outcomes were because the right conversations did not take place with families and carers.</p> <p>He stressed that there was not, nor should there be, a single offer for carers or families. There needed to be a much more nuanced</p>	

	<p>approach, which was why the work beginning in April was so important. The project wanted to hear about lived experiences to help inform their work.</p> <p>WG queried whether Embrace were working with Carers Support Workers. DyC said that the current focus was to gather details of the key people to engage with and undertook to add Carers Support Workers to the list of people to speak with when the design work commenced.</p> <p>MH circulated a presentation by DyC which provided further detail. It could also be accessed with the meeting agenda, on the Healthwatch Cornwall website, here.</p>	
7	Kernow Young Carers Update	
	<p>KD highlighted the key points from his previously circulated report to the Board.</p> <p>Services had been restructured during Covid and face to face activities that were planned from October through to December were changed to online. Around 15 activities were completed, with families joining Teams meetings, including yoga, dancing, comedy workshop etc and resources were delivered direct to families e.g. gingerbread house making at Christmas.</p> <p>Some face to face activities had taken place, particularly with young adult carers, including a socially distanced Christmas meal.</p> <p>156 one to one sessions had been delivered in a socially distanced way, taking young people outside, wearing masks etc. These had been targeted toward higher need cases.</p> <p>84 families received food hampers and gifts at Christmas and 60 families had accessed a Covid winter fund, with an additional £10,000 of funding being brought into the service.</p> <p>70 carers received £10 vouchers provided by Penzance Rotary Club, 10 families were supported through the Mothers Union and 13 families had received help through the Education Fund.</p> <p>In the October to December quarter the referral rate rose to 104, which was comparable with pre-Covid numbers.</p>	

8	Kernow Carers Service Update	
	<p>AS ran through the key points of the October to December quarterly update, as circulated to the Board.</p> <p>NK asked about take up of the virtual forums. AS stated that take up was improving with numbers getting close to pre-Covid attendance.</p> <p>The Forums were scheduled up until the end of June and more information could be found on the Facebook page.</p>	
9	Promas Update	
	Jenny Tarvit and Bernie DeLord of Promas had submitted apologies.	
10	Trust Carers Group Update	
	<p>AF discussed the report circulated with the agenda.</p> <p>Since the beginning of the year, 103 new carers had come online for CFT and there had been 100% take up of the carers assessments offered.</p> <p>January had seen a marked increase in the number of female carers compared to males and there was an increase in emergency mental health cases, including carer breakdowns.</p> <p>There were ongoing issues regarding pressure on beds to support hospital discharges.</p> <p>NK queried who would be carrying out carers assessments under the new service. AF was unclear as to how that had been taken into consideration - under the Section 75 agreement, the Trust Carers Group had done assessments for those aged between 18 and 65 with mental health arrangements and assessments for older people had been done by Kernow Carers Service. This was something that needed to be clarified.</p>	AF to liaise with AN to provide clarification
11	Parent Carers Cornwall	
	<p>SW detailed the content of the Parent Carers report which was circulated by MH during the meeting.</p> <p>The organisation had become more flexible in delivering support to parent/carers during the pandemic.</p> <p>Social media had been used to keep in contact with carers and included a closed Facebook group which offered support for many isolated carers.</p>	

	<p>Weekly e-bulletins had been issued containing signposting information and details of support available etc.</p> <p>Zoom coffee and chat sessions were being held twice a week and there was also a phoneline available to carers to call for support.</p> <p>The group had continued meetings with Health, Education and Social Care, with 66 meetings attended in Cornwall and 8 nationally between October and December.</p> <p>Carers packs continued to be sent out with another 500 packs due to go out to members.</p> <p>AW asked whether some of the packs being sent to GP surgeries could also be sent to Derriford children's ward as those living in South East Cornwall were more likely to access Derriford than Treliske.</p> <p>The Parent 4 Parent service had continued to be busy offering virtual support with completion of forms etc.</p>	SW to liaise with AW
12	Any Other Business	
	<p>Admiral Nurse Service Update</p> <p>CE updated that the Admiral Nurse service was originally based at RCHT to support families of those diagnosed with dementia.</p> <p>The service had been adapted and extended since March and now supported families both if the person was admitted, and also if they lived in their own home.</p> <p>A telephone liaison support service was now offered to families of anyone who had received a formal diagnosis of dementia. This had been working very well and there had been a significant increase in referrals - 100% since last March.</p> <p>Several projects had been put in place through the year, including the Herbert Protocol form now being available in every Co-op store across Cornwall and the Isles of Scilly. Families could complete the form, containing valuable information about an individual with dementia, and keep it in a safe place in the home to be given to search and rescue teams to help find a person if they got lost.</p> <p>Ride the Wave was a pilot scheme due to be launched in March/April, providing a goody bag for families of someone with dementia. The bag would contain a mug, hot chocolate, a note pad and pen and a booklet with all the information they may need about resources in the community. Its purpose was to try and minimise the number of social admissions that were still happening.</p> <p>CE was open to receive referrals - the inclusive criteria being that</p>	

	<p>the person cared for had a formal diagnosis of dementia and the family member consented to the referral.</p> <p>CE was also working with AM on the Carers Passport.</p> <p>NK asked about vaccinations for those people who were not able to give consent and how that was managed. CE advised that the psychiatric liaison team had been doing a lot of work in that area and the dementia falls and practitioner worker had also been working closely on it. CE provided support to the family and the individual through the process.</p> <p>Following a question from AW, SW provided reassurance that for those who were carers of adults with profound learning disabilities there was some planned worked with a team of primary care liaison nurses from CFT, to support the carer and their cared for to get a Covid vaccine.</p> <p>She added that each GP practice had a protocol for desensitisation. However, there would be some individuals who that would not work for and who would require additional support.</p> <p>JL stated that some people had hospital scan appointments booked in January but decided not to go ahead due to the lockdown. However, it appeared that the hospitals had made the decision that those appointments should be cancelled completely, and the individuals would need to be re-referred rather than their appointment being deferred. NK advised that as far as she was aware that was not standard practice and related to a particular specialism. JL said that it was Derriford hospital that had advised patients cancelling a scan that they would need to be re-referred.</p>	NK to investigate.

Your feedback and feedback from practitioners revealed that the current carer's assessment process is not person centred and few carers can access carers support services due to the inefficient way of delivering carer's assessments and the carer's assessment process not being user friendly and proportionate to carers' needs.

The current model of carer's assessment process has changed very little for a long time. The provision of health and social care has evolved significantly during that time. Therefore there are many reasons to consider how the needs assessment for carers can be improved and adapted so carers' outcomes can be met and more carers can access support, within the budget available.

There is an exciting opportunity for you to shape the way how we identify carers' needs and carry out a carer's assessment.

January-March 2021

During this quarter we have continued to support Carers through the Covid-19 pandemic and maintaining supportive resources for carers.

- 330 Carers Assessments were completed during the period.
- Kernow Carers Services enabled 38 carers to access a Kindle Fire tablet and a wellbeing item up to the cost of £40 via the funding obtained from the Carers Trust Connecting Carers & Carer Respite Support Fund.
- KCS also supported a further 28 carers to access an item or activity to support their wellbeing via the KCS Covid-19 Wellbeing Fund.
- Kernow Carers Service has administered the Covid Wellbeing Grant Scheme on behalf of Cornwall Council. This has enabled 98 carers to receive funding to support them to pay for food, utilities and other essential items during this challenging time, with £47,000 going to carers in need.

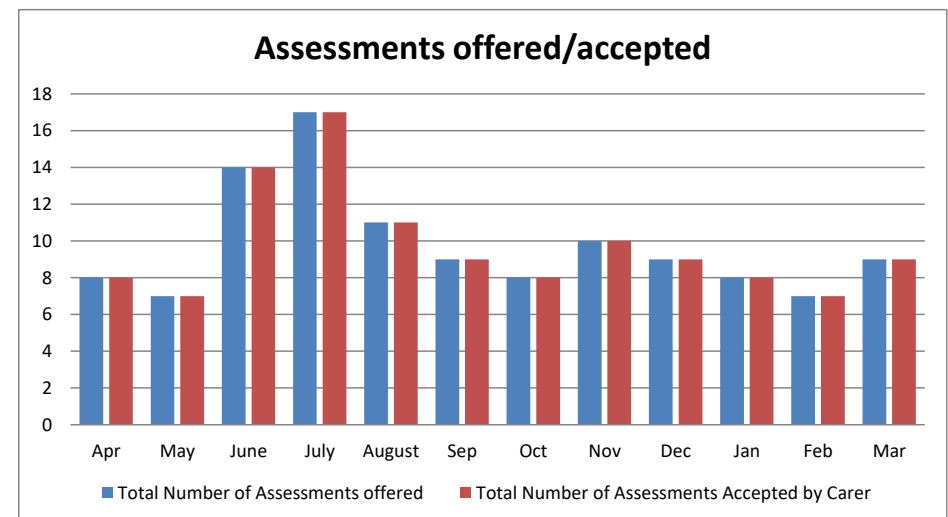
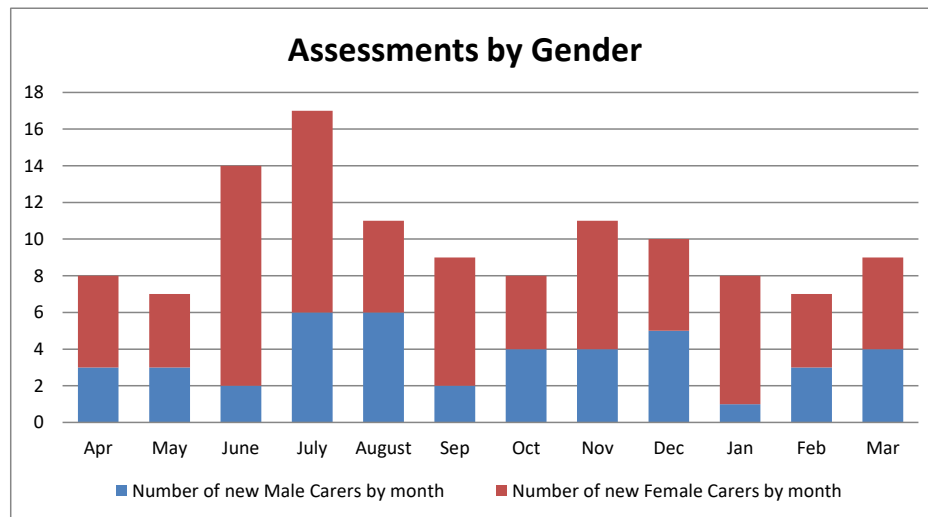

Carers Report January – March 2021

We have continued supporting parent carers since the start of the year with information, advice, and support. These have been in the form of

- Ensuring that social media pages were updated daily with any forms of information that would be useful to parent carers as well as ensuring that contact was available via the closed Facebook page.
- Coffee and chat sessions on a Monday and Thursday via Zoom, open to any parent carer who wanted to socialise, engage with others, ask questions, or request support led by a PCC steering group member.
- E-bulletins – monthly being sent out to all registered parent carers via email and added to the PCC website.
- Newsletter for the New Year and at Easter, again sent out to all registered parent carers, shared with the Cornwall Council, and added to the website.
- Reproduced 5,000 service guides which have gone out to all members and will be distributed to school, early years GPs etc.
- 2 x Carers Resource packs have been sent out to members, these were to promote health and wellbeing.
- We have delivered training workshops via Zoom SPD, PDA, ADHD, ASD. There has also been a transport Q&A seminar and a SEND EHCP seminar.
- We have run online karaoke sessions for young people and parent carers as part of health and wellbeing.
- Leading on the Keyworker programme with CCG which Cornwall is piloting to help reduce hospital admission for those young people with mental health ASD/LD
- Concern is being raised by carers regarding the Lorna Wing which assesses for ASD. GPs can no longer make referrals for assessment with NHS funding. This is causing considerable stress to many families.
