The Learning Disability and Autism Team at **Royal Cornwall Hospital Treliske** are still working to make appointment letters in easy read format



Ambulance crews do not have access to **Hospital Passports** online.

It is very important that you keep the information on your paper passport up to date and carry it with you.



### **Housing Options**

Cornwall Council's Housing Options Manager offered to come to a Board meeting to answer your questions.

No questions were asked so he will not be coming to talk with us.



There is a sub-group of this Board that looks at communication with the **DWP**.

DWP staff will be coming to our December meeting to tell us what they are doing to make **Job Centres** better for autistic people.

The **Adult Autism Assessment Team** is working with the **Mental Health** team to improve support for autistic adults.



Training had been set up with the help of **The Autistic Community of Cornwall**.

Staff all across the Trust should think about neurodiversity in their work.

Christopher Burns said that autistic people in Cornwall needed more support.

There was no **Social Prescriber** in the Torpoint area.

Some people were having to get help from outside of Cornwall to complete PIP forms.

Robert O'Leary used to be a Social Prescriber. He would talk to Christopher outside of the meeting top find out more.

Sara Sanders is the new lead for **LeDeR**.

LeDeR reports give information about the lives and deaths of people with a learning disability and/or autistic people.


It is very important information as it can be used to improve lives.

Christopher Burns and Stuart Ralphson have been doing disability awareness work for **Torpoint Diverse Advisory Panel**.

Stuart read 'This is Me!' by George Webster to parent carers and children at Torpoint Library.

It is hoped that it can be done at all libraries across Cornwall

Liz Cahill gave a presentation about the new **"Celebrating Neurodiversity" Strategy** for Cornwall and the Isles of Scilly.

It will be agreed by the Council's Cabinet in December.

No easy read information was available yet.

The four key themes are:

- Cultural change with a focus on outcomes
- Diversity not deficits
- Focus on "need" not just diagnosis
- Earlier help.

The Board said it is important that all professionals are trained about neurodiversity.

The draft Strategy was emailed to all members so they could have their say but it was not in easy read.





Sarah Keates from Cornwall Council gave an easy read presentation about the **Cornwall Supported and Specialist Housing Strategy**.
